

Maine Two-Foot Narrow Gauge

Gus Pratt & Stephen Hussar DVDs Presented by Ira Schreiber

February 14th, 2012 • 7:30 PM

Armed with a 16mm movie camera, 17-year old Gus Pratt set out in 1935 to document Maine's unique 2-foot gauge railroads. Growing up in rural Maine in the 1930s, he saw the narrow gauge dwindling and decided to capture it on film. He would show his Sandy River films now and then at meetings of the 470 Club, but for the most part kept the films locked away for over 60 years. Gus followed the rebirth of the Wiscasset, Waterville and Farmington Railway with great interest, and in 2006, at 88 years old, he donated his narrow gauge films to the WW&F Museum,







A recent estimate by BNSF indicates that building FasTracks rail service to Longmont, Colorado, will cost more than expected. The railway surpassed RTD's original estimate of \$894.4 million to a new figure of \$1.4 billion, based on costs for double tracking and sidings, environmental protection and moving utilities, and the cost to operate and maintain the train service. Year 2020 was considered to be the soonest that the Northwest Rail line could be completed, if voters approved a four-tenths of a cent sales tax hike.

Union Pacific reported it had another record-setting quarter in the last three months of 2011, and the year had been its most profitable ever. U.P. says 2012 is projected to be another top year, with

plans to spend a record \$3.5 billion on capital improvement projects. About \$1 billion of that will be within Nebraska over the next few years. As part of UP's 150th birthday celebration, this special website was launched in January and includes news, schedules and special interactive features: www.up150.com

Musket Corporation plans to open a crude-oil export terminal at Windsor, Colorado, for unit train shipments using a newly constructed four-mile loop on the Great Western Railway, which interchanges with BNSF and Union Pacific. The 320-acre site at the Great Western Industrial Park has fuel storage tanks with 48,000 barrels of capacity, which

will be converted to crude oil service. The site will have initial loading capacity of 5.8 million barrels a year and is designed for expansion.

GE Transportation plans to establish a new production facility in Grove City, Pennsylvania, to meet growing demand for diesel engine remanufacturing services. This increase is driven by routine locomotive overhaul cycles and the need to comply with EPA Tier 3 emissions standards for diesel engines by 2013. The new plant will be located at an existing site where General Electric currently makes about 2,000 new engines a year.

delivered 3,300 new rail cars in the recent quarter, compared with 1,050 in the same period a year ago.

U.S. railroads reported gains in 2011 rail traffic compared with the previous year, originating 15.2 million carloads, up 2.2 percent over 2010 and up 9.7 percent over 2009.

trackage in South Dakota had been saved by the efforts of then-governor Bill Janklow. In the early 1980s he had persuaded the state legislature to buy the lines which were largely absorbed later into the BNSF. He was 72 when he passed away in January.

Denver & Intermountain Interurban Car No. 25 Is Officially A National And State Register Historic Property

The National Register in Washington recently communicated that Car No. 25 was listed as a National and State Register property on January 12, 2012.

From The West Corridor Historical Rail Cooperative Board

In late December, 2011, the Denver Rail Heritage Society (DHRS) sold its share of ownership to Car #25 (through the West Corridor Rail Cooperative - WCRC) to the City of Lakewood. The City of Lakewood and the DHRS had formed the nonprofit WCRC to purchase Interurban Car #25 from the Rocky Mountain Railroad Historical Foundation in 2010. The DHRS and the City of Lakewood were each 50% owners in the Cooperative, with two members representing each organization on the WCHRC Board of Directors.

During 2011 it became apparent that this WCRC model was not as practical as envisioned, although it provided an excellent method of ensuring the future of Car #25. In December, both the DHRS and City of Lakewood agreed that if Lakewood became the single owner it would enable many of the visions for Car #25 to be realized. The City of Lakewood is committed to building the Oak Street Transit Museum to house Car #25. The car will be integrated into the Heritage, Culture and the Arts Division of the City of Lakewood as an extension

of its focus on 20th Century Lakewood history. The Heritage, Culture and the Arts Division also manages Lakewood's Heritage Center 20th Century Museum, The Lakewood Cultural Center and the Washington Heights Arts Center.

Fundraising efforts will continue by the City through the Heritage, Culture and the Arts Alliance (www.alliancechca.org), a 501c3 nonprofit organization whose mission is to raise funds and increase awareness for heritage, cultural, arts, and educational programs of the City of Lakewood's Heritage, Culture, and the Arts Division. Spring 2012 will kick off a Capital Campaign for the Transit Museum and the City of Lakewood will need the help and support of volunteers and the community to make the plans for the Oak Street Transit Museum a reality. The City of Lakewood, the Denver Rail Heritage Society and the Rocky Mountain Railroad Club and Foundation are committed to continuing to work together as collaborators to support Car #25 and to promote a regional vision for historic transit.

The American Society for Testing and Materials

The ASTM, an organization that develops industrial standards, recently announced the formation of a subcommittee that will turn its attention to min-

ature railroads. Subcommittee F24.60, Special Rides / Attractions, is working on two proposed standards for amusement ride trains.



The City of Lakewood continues to move forward on the Oak Street Transit Museum. Once an architectural and engineering firm team is selected, the City will move forward with design and construction documents. This conceptual renderings of the Oak Street facility was unveiled at the 100th celebration a year ago. The design will be refined during architectural process.

The Club Seventy Years Ago

In 1942, the Club established the process of issuing numbered membership cards. At that time there was no Club roster and membership was less than one hundred. Many Club members would be forced to give up participating in Club activities as World War II grew in intensity. Meetings were held in the Sixth Floor Executive Board Room of the Denver & Rio Grande Railroad Company general offices at 1531 Stout Street.

Preston George was President, Otto Perry was Secretary and Joe Schick was Treasurer (even though no dues were collected). Carl Hewett was the editor of the *Rocky Mountain Rail Fan* (the predecessor to the *Rail Report*). Issue number 4 in 1942 was the first issue in nearly two years. Hewitt's prose was noteworthy for his passion and love of steam operations

in Colorado. There is no record of the Club having any excursions or field trips in 1942.

Also from the 1942 *Rocky Mountain Rail Fan*: "Probably the most important gain each of us can count consists of the many pleasant friendships we have formed during these four and a half years. We started out merely as a widely assorted group of individuals drawn together by the fact that, regardless of age, we had never outgrown our childhood fascination for "Choo-choo" trains. We have found keen satisfaction in pursuing our hobby in company with kindred spirits and we have each increased our knowledge of railroad history, locomotive photography and current railroad events by participating in the pool of such knowledge that accumulates at each Club meeting."
